# Code Corner – Garage Sales & Selling Items in Frost

Planning a garage sale or selling items in Frost? Here's what you need to know:

## Garage Sale Permits

- Required Permit: A written permit is mandatory for all garage sales. Applications must be submitted at least three (3) days prior to the sale's start date.
- Fees: The first permit of the year is free. Subsequent permits are \$5 each. Nonprofit organizations are exempt from permit fees.
- Permit Revocation: Permits may be revoked if the sale causes undue traffic congestion, disturbances, or breaches the peace.

# **Sale Duration & Frequency**

- Duration: Sales are limited to three (3) consecutive days between sunrise and sunset.
- Frequency: A maximum of three (3) garage sales per year is permitted per residence.

# Signage Regulations

Size & Placement: Signs must be no larger than three (3) feet in height and placed on **private property only**. Off-premise signs require approval from property owners.

- Number of Signs: Up to three (3) signs on the sale property and one (1) offpremise sign are allowed.
- Timing: Signs may be displayed from 5:00 p.m. the day before the sale until 8:00 a.m. the day after. A fine will be assessed for each sign left after the required removal time.

### Selling Items

- **Eligibility**: Sales must involve **personally owned, used goods**. Items purchased for resale are prohibited.
- Location: Sales must occur at the residence of the seller or a nonprofit organization's property.
- Conduct: Sales should not cause disturbances or nuisances in the neighborhood.

#### Penalties

Violations of these regulations can result in fines up to **\$500** for each offense. Continuous violations may incur additional penalties.
