Minutes

In accordance with the Texas Open Meetings Act (TX. GOVT. CODE, Title 5-C, Chap. 551), Frost City Aldermen held a Regular Business Meeting at 6:00 P.M. May 12, 2025 at City Hall, 100 N. Garitty St. Present: Aldermen: Amber Whitley, Shannon Wayman, Megan Welborn, and Johnny Sutton. Absent: Mayor Anthony "Tony" Harris, Alderman Stormi Upton. Others present: Juli Reeves, Velma Ballew, Debra Feuerherdt and Emilie with NavCo Chronicle. .

1. A quorum was established, and the meeting began at 6:00 P.M. with the Pledge of Allegiance to the United States Flag and Texas Flag, followed by the invocation given by Mayor Anthony "Tony" Harris.
2. Mayor Harris appointed Johnny Sutton and Shannon Wayman to canvas the May 3, 2025 elections results.
3. Canvas of election was held for Proposition A – The adoption of an additional sales and use tax within the city at the rate of 0.5% and the results were 80 votes for and 43 against, passing by a margin of 37 votes.
4. Canvas of election was held and the resulting winners were announced to be Megan Welborn, Stormi Upton and Amber Whitley.
5. Council member Shannon Wayman made a motion to approve the canvass of the May 3, 2025 General Election and declare the results as presented, Councilman Johnny Sutton seconded, motion passed.
6. Mayor Harris presented Certificates of Election to newly elected and returning Aldermen.
7. City Secretary, Juli Reeves, received the Statement of Officers and administered the Oath of Office to newly elected and returning Aldermen.
8. Ron Franks vacated his seat as Alderman in order to allow newly elected Aldermen to take a seat and begin administering their duties.
9. Review, discuss & approve quotes for bush hog for the utility department. Quotes received were from John Deere for a RC6M Lift Type Rotary Cutter 540 RPM PTO for \$4200.00, Tipton International, Inc. for an RCF2072 Shredder for \$3000.00 and from PR Equipment for an Iron Craft 6' Standard Duty Rotary Cutter for \$2150.00, an Iron Craft 6' Standard Duty Cutter w/Slip clutch for \$2750.00 and a Rhino TW25 5' Rotary Cutter for \$3800.00. A discussion was held on the different brands and the prices and Alderman Amber Whitley asked about maintenance and instructions for utility workers to follow and implementing a maintenance schedule and making sure it is being done. Motion was made by Alderman Shannon Wayman to purchase a 6' Standard Duty Cutter w/Slip Clutch for \$2750.00 from PR Equipment, Kerens, TX. Second was made by Alderman Stormi Upton, motion passed.
10. Alderman Johnny Sutton mad a motion to adjourn, Alderman Megan Welborn seconded, motion passed. Meeting adjourned at 6:17 p.m.
