CODE, Title 5-C, Chap. 551), Frost City Aldermen held a Regular/Called Business Meeting and Public Hearing at 6:00 P.M., September 08, 2020 at City Hall, 100 N. Garitty St. Present: Mayor Scott Dowdle, Aldermen, Velma Ballew, Johnny Sutton, Rachel Cagle, Rudy Salinas, Jimmy Bratcher, Others present, Terry McGill, Dottie and Bill Barnes, Jimmy Alexander, Chief Scott Sykora, Frost ISD Chief of Police Curtis Kaloi.

1. A quorum was established and the meeting began at 6:00 P.M. with the Pledge of Allegiance and Invocation Velma Ballew
2. Public Hearing to receive comments on City's purposed tax rate of 0.490100/\$100 for the 2020 Purposed Tax Rate. Jimmy Alexander spoke about taxes going up every year.
3. Public Hearing to receive comments on the Purposed 2020-2021 Budget. Jim Barnes commented on the tax rates and comments on raises.
4. Citizen's Comments. Velma Ballew announced date and time of community bake sale, garage sale, and fire department breakfast and lunch pick up.
5. Following a Motion by Johnny Sutton and 2nd by Rachel Cagle the council voted to approve the Purposed Budget for 2020-2021. Velma Ballew Aye, Johnny Sutton Aye, Rudy Salinas Aye, Rachel Cagle Aye, Jimmy Bratcher Nay.
6. Following a Motion by Velma Ballew and 2nd by Johnny Sutton, council voted to approve ratification of the property tax revenue increase reflected in the 2020-2021 budget.
7. Following a Motion by Johnny Sutton(I move that the property tax rate of \$0.4901 per \$100 assessed value of taxable property be adopted.) 2nd by Rudy Salinas the council voted to adopt Ordinance No. 312 levying a tax rate of \$0.4901 per \$100 for 2020. Velma Ballew Aye, Johnny Sutton Aye, Rudy Salinas Aye, Rachel Cagle Aye, Jimmy Bratcher Nay.
8. Following a motion by Johnny Sutton and 2nd by Rudy Salinas the council voted to adopt Ordinance 311 increasing trash rates.
9. Following a motion by Velma Ballew and 2nd by Johnny Sutton council voted to approve the Amended Budget for 2019-2020.
10. Following a motion by Jimmy Bratcher and 2nd by Johnny Sutton council voted to approve Resolution 170: APPROVING A NEGOTIATED SETTLEMENT BETWEEN THE ATMOS CITIES STEERING COMMITTEE AND ATMOS ENERGY, REGARDING THE COMPANY'S 2020 RATE REVIEW MECHANISM FILING.
11. Following a motion by Velma Ballew and 2nd Rachel Cagle approved Resolution 171 joining Buy Board, Which is a Buyer's Cooperative.
12. The Results of the Audit for 2018-2019 done by Anderson, Marx & Bohl was discussed.
13. Following a Motion by Johnny Sutton and 2nd by Velma Ballew the consent items for August were approved
14. The Meeting was adjourn at 8:30 PM.
